

## घटिया विधायक मालवी के खिलाफ चौथी बार गिरफ्तारी वारंट

ज्जेन। भाजपा नेता पर जानलेवा हपले के मामले आरोपित घटिया विधायक सतोश मालवीय खेलाफ कोर्ट ने सोमवार को फिर से चौथी गिरफ्तारी वारंट जारी किया। 25 जुलाई को जारी वारंट में पुलिस को निर्देश दिए थे कि वह 6 अगस्त को विधायक को कोर्ट में पेश करे। लेकिन सोम को पुलिस ने कोर्ट में प्रतिवेदन देकर कहा कि विधायक की तलाश की गई लेकिन वह नहीं मिला कारण और समय दिया जाए। कोर्ट ने चौथा वारंट जारी कर 10 सितंबर तक का समय दिया है। इस कोर्ट ने एसपी सचिन अतुलकर को पत्र लिखा है कि वह विशेष रुचि लेकर विधायक को गिरफ्तार वारंट में पेश करे। उल्लेखनीय है कि पुलिस ने रवि को विधायक मालवीय की तलाश में उसके शिव मार्व स्थित घर तथा फ्रीगंज स्थित द्वारकामार्ग पर दरबारा दी थी। मगर वह हाथ नहीं दे सका। अधिकारियों का कहना है कि वह इन दिनों दिल्ली में इस कारण पकड़ा नहीं जा सका।
